# AMENDMENT TO ORDINANCE NO. 19-11C AN ORDINANCE OF THE BOARD OF DIRECTORS OF

# WEAVERVILLE COMMUNITY SERVICES DISTRICT ESTABLISHING FEES, RATES AND CHARGES

BE IT ORDAINED by the Board of Directors of the Weaverville Community Services District as follows:

Section 5, of Ordinance No. 23-02 is amended, effective August 01, 2023, in its entirety to provide as follows:

**Section 5.** <u>Water Rates:</u> Each installed water service shall be charged a basic rate using the following schedule.
