## EMPLOYMENT OPPORTUNITY FIELD SERVICEMAN I/II

**The District-** Weaverville Community Service District provides domestic water service to the town of Weaverville. Located in Trinity County, California, Weaverville (population 3700) lies approximately 50 miles west of Redding California on Highway 299w in a beautiful mountain valley surrounded by the Trinity Alps Wilderness Area. The district supplies domestic water to the communities of Weaverville and Douglas City. Trinity County is known for clean air, clean water, unlimited recreation and no traffic lights in the entire county.

The domestic water system consists of three surface water treatment plants with a combined capacity of 3.3 MGD. Six storage reservoirs, three pump stations that are all integrated with a state of the art SCADA system.

## PRINCIPAL DUTIES AND RESPONSIBILITIES:

Independently or under direct supervision of the General Manager, Field Service Personnel are responsible for the operation and maintenance of district facilities and/or systems, including but not limited to the following:

- <u>Water Treatment Facilities</u> Perform lab tests, adjust chemical dosages, monitor and adjust inflows/outflows, inspect and maintain plant equipment and systems
- <u>Domestic Supply System</u> Operate, maintain and repair distribution facilities, install new services, read meter and respond to customer calls.
- <u>Overall Operation</u> Assist in construction and/or maintenance of general district facilities, including but not limited to properties, buildings and equipment.

## MNIMUM QUALIFICATIONS

Desired candidate experienced in the operation and maintenance of a domestic water treatment facility as a T1/T2 operator. Experience in operation and maintenance of domestic distribution system as a D1/D2 highly desirable. High school graduate or equivalent. Valid CA drivers license w/clean record mandatory. Employment contingent upon successful pre-employment physical and drug test. References required.
